This draft circular applies for all agencies, organizations and individuals involved in design, manufacture, assemble, import, upgrade, restoration of railway cars for all railway networks and organizations involved in managing, inspecting, testing and certificate granting.

This draft Circular shall replace the Circular 63/2015/TT-BGTVT Stipulation of inspection of quality, safety technical and environment protection for rolling stock
