 - This draft regulation applies to organizations involved in manufacturing, assembling, repairing of locomotives, railway cars; organizations manufacturing, importing the materials for interior structure of railway coaches, cabins of locomotives and agencies, organizations and individuals involved in inspecting, testing and certificate granting of quality, technical safety and environment protection for rolling stock.
