- **Title, number of pages and language(s) of the notified document:** The draft National technical regulation on wheel-sets for rolling stocks (18 page(s), in Vietnamese)

 - This draft regulation stipulates the inspection of wheel-sets for locomotives, railway car whose speed is not much more than 120 km/h for meter gauge (1000 mm) and not much more than 160 km/h for standard gauge (1435 mm).
 - This draft regulation applies to organizations involved in manufacturing, assembling of locomotives, railway cars; organizations manufacturing, importing the wheel-sets and agencies, organizations and individuals involved in inspecting, testing and certificate granting for quality, technical safety and environment protection.
