Description of content:</b> This draft technical regulation shall regulate the collection, transportation, storage, recycling, reclaim and disposal of ozone-depleting substances, causing greenhouse effects substances under the Montreal Protocol on substances that deplete substances (referred to as controlled substances) used in refrigeration and air-conditioning equipment (hereinafter referred to as "equipment"). The list of controlled substances is specified in the Circular No. 01/2022/TT-BTN MT dated 07 January, 2022 by the Minister of Natural Resources and Environment on guidelines for implementation of the Law on Environmental Protection regarding response to climate change.

	<p>This draft technical regulation does not specify safety requirements in production and installation. The product is designed, manufactured, assembled and installed to comply with recognized safety requirements.</p> <p>This draft technical regulation will apply to agencies, organizations and individuals involved in the collection, transportation, storage, recycling, reclaim and disposal of controlled substances.</p>
