- **6. Description of content:** This draft Technical Regulation stipulates requirements on safety, testing, conformity certification of protective equipment in martial arts produced domestically and imported and circulated on the market, including the following equipment:
  - Equipment for trunk protectors;
  - Equipment for head protectors;
  - Equipment for genital protectors.

This draft Technical Regulation applies to manufacturers, importers, distributors and retailers of martial arts protective equipment and organizations, individuals involved in the management, testing, conformity certification of protective equipment in martial arts which are within the scope of this draft Technical Regulation.
