5. Title, number of pages and language(s) of the notified document: Draft National technical regulation on bogies of locomotives and railroad cars; (33 page(s), in Vietnamese)

Description of content: This draft National Technical Regulation stipulates technical requirements and inspection of technical safety and environmental protection quality for manufactured, assembled and imported bogies used on locomotives and railroad cars. This draft National Technical Regulation applies to organizations and individuals involved in the design, manufacturing, import, inspection and certification of technical safety and environmental protection quality of bogies used on locomotives and railroad cars with HS code of 8607.11.00 and 8607.12.00, respectively, as prescribed in Circular No. 31/2022/TT-BTC dated June 8, 2022 of the Minister of Finance promulgating the List of Vietnam's export and import goods. The draft National Technical Regulation does not apply to bogies used on high-speed railway vehicles, military and police railway vehicles used for defense and security purposes.
