This regulation only applies to LED lighting products within the scope of application of the corresponding safety standards listed in Appendix A of this regulation.

This technical regulation does not apply to:

LED lighting products in traffic lighting projects, urban centers, concentrated residential areas and public spaces (public entertainment areas, squares, parks and flower gardens);

LED lighting products for means of transport;

Explosion-proof LED lighting products.

This draft technical regulation applies to organizations and individuals that manufacture, import and commercialize LED lighting products (hereinafter referred to as Enterprises) listed in Appendix A of this technical regulation, conformity assessment organizations, state management agencies and other relevant organizations and individuals.
