Description of content:** This draft regulation specifies the technical requirements to ensure the safety of free-standing pesticide spraying equipment carried on the back and shoulders of the operator by straps, in which the spraying fluid pressure created by liquid pump or air compressor pump (hereinafter referred to as injection pump), used to spray liquid chemicals and biological products for the purpose of care and protection of plants and animals.
