6.	<b>Description of content:</b> This new technical regulation defines requirements on EMC and radio spectrum for transmitting equipment for amplitude modulated sound broadcasting service operating in the MF band, from 526.5 kHz to 1606.5 kHz; and HF band, from 3.2 MHz đến 26.1 MHz. The technical regulation is based on ETSI EN 302 017-2 V1.1.1 (2005-09) of European Telecommunications Standards Institute (ETSI). The technical regulation will be served as a basis for conformity assessment of amplitude modulated sound broadcasting equipment.
