Among other things, under this draft Decree, the labelling, packaging and transportation of chemicals, insecticides and disinfectants shall satisfy specific requirements, as being regulated correspondingly in Article 28. Labelling chemicals, insecticides and disinfectants, Article 29. Packaging chemicals, insecticides and disinfectants and Article 30. Transporting chemicals, insecticides and disinfectants.
