5.	Title, number of pages and language(s) of the notified document: National technical regulation on electromagnetic compatibility and radio spectrum requirements for terrestrial digital television broadcast transmitting equipment (available in Vietnamese, 24 pages).
6.	Description of content: This new technical regulation defines requirements on EMC and radio spectrum for transmitting equipment for the terrestrial digital television broadcasting service with 8 MHz RF channel bandwidths, operating in the CEPT frequency bands. These frequencies are currently within bands I, III, IV and V. The technical regulation is based on EN 302 296 v1.1.1 (2005-01), EN 301 489-1 v1.2.1 (2000-08) and EN 301 489-14 v1.2.1 (2003-05) of European Telecommunications Standards Institute (ETSI). This technical regulation will be served as a basis for conformity assessment of transmitting equipment for the terrestrial digital television broadcasting service.
