5.	<b>Title, number of pages and language(s) of the notified document:</b> National technical regulation on the basic safety of high frequency surgical equipment (12 pages, in Vietnamese)
6.	<b>Description of content:</b> This regulation applies to agencies, organizations and individuals that manufacture, export, import and use the High Frequency Surgical Equipment for medical purposes in the territory of Vietnam. The regulation defines safety requirement of high frequency surgical equipment in medical purpose. It does not apply to equipment which have rated output power less than 50W.
7.	<b>Objective and rationale, including the nature of urgent problems where applicable:</b> Medical devices have direct impact on the health of patients, therefore the most concerned issue is the safety of the device. On 6 December 2011, the Ministry of Health promulgated Circular No.44/2011/TT-BYT on the list of products and goods likely to be unsafe subject to the management assigned to the Ministry of Health. In this Circular, high frequency surgical equipment is listed in products and goods Group No. 2 Equipment of direct intervention on the patient. In addition, high frequency surgical equipment are now being imported into Vietnam and more widely used in the medical facilities. Therefore, technical standards defining safety criteria for high frequency surgical equipment should be developed to ensure the quality thereof during manufacturing, importing and use.
