The technical requirements and test methods for regulated products are in the relevant National Standards (TCVNs) that are identical to the related IEC Standards. Certification model: system 1 (Type testing) Type testing of products, goods in order to draw a conclusion of conformity. The conclusion of conformity has a value to the type of products, goods which have been sampled for testing. Certified products shall bear the Conformity Mark before circulation in domestic market.
