Description of content: This draft technical regulation specifies the limits of cryptographic technical characteristics for data security products used to protect information which are not within the scope of state secrets This draft technical regulation applies to organizations and individuals engaged in the production, trading and use civil cryptographic products intended to protect information outside the scope of state secrets The Government Cipher Committee will accept test results from designated domestic conformity assessment organizations, as well as from recognized or unilaterally recognized conformity assessment organizations according to the provisions of law for the technical requirements in this technical regulation.
