Description of content: This draft National Technical Regulation (NTR) specifies technical requirements and the inspection of technical safety quality and environmental protection for newly manufactured, assembled, and imported brake valves (locomotive distributor valves, rolling stock brake valves) for locomotives and rolling stock. This draft NTR does not apply to brake valves of urban railway rolling stock, locomotives and rolling stock with designed speed greater than 120 km/h; locomotives and rolling stock belonging to the military or public security (police) used for national defense and security purposes. This draft NTR applies to organizations and individuals involved in the management, production, assembly, import, inspection, certification of quality, technical safety and environmental protection of brake valves of locomotives and carriages within the scope of regulation in point 1.1
