6. Description of content: This draft National Technical Regulation (NTR) specifies technical requirements and the inspection of technical safety and environmental protection for railway vehicles during periodic inspection, modification, and import of used vehicles.

This draft NTR does not apply to rail vehicles with designed speed greater than 120 km/h, rail vehicles belonging to the military or public security (police) used for national defense and security purposes, modified or imported used urban railway rolling stock.

This draft NTR applies to organizations and individuals involved in the management, repair, maintenance, import, modification, exploitation, inspection and certification of technical safety and environmental protection of railway vehicles within the scope of regulation in point 1.1.

7. Objective and rationale, including the nature of urgent problems where applicable: Protection of human health or safety; Protection of the environment; Quality requirements
