Description of content: This draft National Technical Regulation (NTR) specifies technical requirements and the inspection of technical safety quality and environmental protection for newly manufactured, assembled, and imported Diesel locomotives and self-propelled railway vehicles for special purposes operating on Vietnam's railway system. This draft NTR does not apply to the following types of vehicles: a) Diesel locomotives and self-propelled railway vehicle for special purpose belonging to the military or public security (police) used for national defense and security purposes; b) Rail vehicles with designed speed greater than 120 km/h.

This draft NTR applies to organizations and individuals engaged in the management, production, assembly, importation, certification, and conformity declaration of vehicles within the scope of regulation in point 1.1.
