- **6. Description of content:** This draft National technical regulation specifies technical requirements and the inspection of technical safety quality and environmental protection for the following types of vehicles:
 - a) Newly manufactured, assembled, and imported rolling stock and non-self-propelled vehicles for special purpose.
 - b) Newly imported urban railway rolling stock.

This draft National technical regulation does not apply to the following types of vehicles:

a) Railway vehicles belonging to the military or public security (police) used for national defense and security purposes.

b) Railway vehicles with designed speed greater than 120 km/h; imported used railway vehicles, and manufactured, assembled urban railway rolling stock.

This NTR applies to organizations and individuals involved in the management, production, assembly, import, inspection and certification of vehicle types within the scope of regulation in point 1.1.

7. Objective and rationale, including the nature of urgent problems where applicable: Protection of human health or safety; Protection of the environment; Quality requirements
