Description of content: This draft National technical regulation (NTR) specifies technical requirements and the inspection of technical safety quality and environmental protection for bogies manufactured, assembled, and imported for locomotives and rolling stock operating on Vietnam's railway system. This draft NTR does not apply to bogies of locomotives and rolling stock with designed speed greater than 120 km/h, bogies of railway transport vehicles belonging to the military or police used for national defense and security purposes. This draft NTR applies to organizations and individuals involved in the design, production, assembly, import, inspection and certification of technical safety quality and environmental protection for bogies of locomotives and carriages within the scope of regulation in point 1.1.
