Description of content: This draft Decree promulgates lists of chemicals subject to management under the Law on Chemicals No. 69/2025/QH15. These lists are provided in 05 Annexes, as follows:

Annex I: List of basic chemicals in prioritised chemical industry sectors;

Annex II: List of chemicals subject to conditional production and trading;

Annex III: List of chemicals subject to special control in production and trading;

Annex IV: List of chemicals required to prepare a Chemical Accident Prevention and Response Plan;

Annex V: List of training disciplines eligible to conduct chemical safety activities.

This draft Decree applies to domestic agencies, organizations and individuals and foreign organizations and individuals conducting activities related to chemicals in the territory of Vietnam.
