5. Title, number of pages and language(s) of the notified document: Joint Ministerial Circular of Ministry of Health and Ministry of Industry and Trade on the labelling and printing of the health warnings on the packet of tobacco products (8 pages, in Vietnamese and English).
6. Description of content: In 18 June 2013, the National Assembly issued the Tobacco Control Law. This is the first and comprehensive legal document on Tobacco Control work in Vietnam. Pursuing to the Article 15 of Law, Tobacco products manufactured in or imported into Vietnam for consumption shall be labeled and printed with the health warnings. The Minister of Health to take prime responsibility and collaborate with the Minister of Industry and Trade to issue detailed regulations on this issue. Thereof, the Ministry of Health and the Ministry of Industry and Trade has drafted this Circular. It regulates labeling and printing of the health warnings on the packet of tobacco that are manufactured and imported for consumption in Viet Nam. Both domestic and foreign entities and individuals who do and participate in the business of tobacco products in the territory of Viet Nam shall comply with the regulations of this Circular.
7. Objective and rationale, including the nature of urgent problems where applicable: Protection of human health.
