Description of content: The draft national technical regulation on importing and dismantling used ships stipulates the technical requirements, permissible limits of pollutants, and environmental protection provisions for the importation and dismantling of used ships brought into Vietnam for dismantling (excluding military ships, nuclear-powered ships, and ships carrying radioactive materials).

This draft national technical regulation applies to organizations, individuals, state administrative agencies, conformity assessment bodies, inspection agencies, and environmental monitoring entities involved in the importation and dismantling of used ships brought to Vietnam for dismantling.
