Description of content: This draft Decree details a number of provisions and implementation measures for the Law on Standards and Technical Regulations 2006 and the Law on Amendments and Supplements to a Number of Articles of the Law on Standards and Technical Regulations 2025 (hereinafter referred to as the Law on Standards and Technical Regulations). It covers the development and promulgation of standards; development and issuance of technical regulations; activities in the field of standards, technical regulations, assessment of conformity with standards and technical regulations; responsibilities of agencies, organizations and individuals engaged in these areas.

This Decree details a number of articles and measures for implementation of the Law on Standards and Technical Regulations, the Law on Investment with respect to business conditions in conformity assessment services.

This draft Decree applies to Vietnamese organizations and individuals, foreign organizations and individuals, and Vietnamese people residing abroad whose activities are related to the fields of standards, technical regulations, and conformity assessment activities.

Objective and rationale, including the nature of urgent problems where applicable: Protection of human health or safety; Protection of animal or plant life or health; Protection of the environment; Quality requirements; Harmonization; Reducing trade barriers and facilitating trade; Cost saving and productivity enhancement
