Description of content:</b> This draft National Technical Regulation stipulates technical requirements for inspection, testing, and certification of technical safety and environmental protection quality applicable to the production, assembly, and import of new electric motors used for electric motorcycles and electric mopeds.  This draft National Technical Regulation applies to: Domestic manufacturing and assembly establishments; Organizations and individuals importing electric motors; Organizations and individuals involved in the management, inspection, testing, and certification of technical safety and environmental protection quality of electric motors.
<b>7. Objective and rationale, including the nature of urgent problems where applicable:</b> Protection of human health or safety; Protection of the environment; Quality requirements
