5. Title, number of pages and language(s) of the notified document: Draft National Technical Regulation on Safe Work for Room-Less Electric Lift (11 pages, in Vietnamese)
6. Description of content: This draft technical regulation applies to room-less electric lifts (hereafter referred to as electric lifts) which are installed rigidly, used to transport human or products accompanied by human. Other lifts operating under strict modes for special objects and operation scopes (for instance chemical transport, explosive materials) and operating in abnormal environment, in addition to compliance to this regulation, shall comply with other regulations specified by other agencies authorizing in safe work or fire fighting and prevention. This regulation applies to organization and individuals who produce, import, make available and use electric lifts, state management agencies and relevant organization and individuals.
