SUMMARY:

Amend a number of articles of Decree 113/2017/ND-CP of the Government dated on 9th October 2017 guiding the implementation of a number of articles of the Law on Chemicals, including:

1. Declaration of imported chemicals;
2. Exercises of Measures for Chemical Incident Prevention and Response;

- 3. Exemption for some cases of Certificate for production and trading of chemicals subject to conditional production and trading in the industrial sector and License for production and trading of restricted chemicals manufacturing and trading in the industrial sector;*
- 4. Simplifying the application for the Certificate for production and trading of chemicals subject to conditional production and trading in the industrial sector and the License to produce and trade of restricted chemicals manufacturing and trading in the industrial sector;*
- 5. Adding the duration of the License for production and trading of restricted chemicals manufacturing and trading in the industrial sector;*
- 6. Management of industrial precursors;*
- 7. Adding practical content to the chemical safety training program;*
- 8. Adjustment of time for reporting chemical activities;*
- 9. Adding chemicals to the list of prohibited chemicals and restricted chemicals from production and business in the industrial sector.*
